

We embrace the major activities globally recommended in project planning and work hand in hand with the project teams of the respective organisation, individual or government with due regard to the clients' aspirations.


#### **Environment, Monitoring, Analysis & Evaluation**


We assist our clients in drafting and structuring of related policies and procedures and any reforms or project activities designed to promote market reform, encourage private sector development, or strengthen trade and investment.


# General Programs Contracting in Infrastructure Development


